1. Call to Order - Roll Call - Establish Quorum

No public comments were made.

3. FOR DISCUSSION AND POSSIBLE ACTION

A. Approve minutes for 2023-03-22 meeting.
 No public comments. Trustee Richard moved to approve. Trustee Dana seconded. Unanimously passed.

B. Auditor RFP & Approval - Trustee Nice

Only one response to our RFP to ~ 10 different accounting firms. Estimated at \$28k for first year. Our accountant felt the price was reasonable. This audit is required per our loan agreement with the USDA. Audit needs to begin in May.

Public Comment: Jane Geisse (1074 Skyland Dr) feels we're stuck with only one option. Larry Sidney (189 Myron Dr) raised the point that a first year audit may be more expensive than subsequent years.

Trustee Comment: Karl raised questions about requirements of the audit firm, Richard answered. Scott asked if we have a motion to engage with Haynie & Co. Richard moved to engage for the \$28k audit. Nancy seconded the motion. Vote: Dana-yes, Karl-yes, Nancy-yes, Richard-yes, Scott-yes. Unanimously approved. Trustee Richard to follow-up.

C. Election / Appointment of Secretary
Some discussion, the board agreed to table for now with the role shared between Trustees
Scott & Nancy for now.

4. COMMITTEE REPORTS

A. HWY50 & Bike Path Committee, present, discuss, and recommend next steps.
No public comment. Trustee Dana reports that much of the concerning changes have been tabled for the time being. Survey crews have been reviewing the highway. Hoping we can get

Resident Elizabeth Lernhardt to attend soon to provide a more detailed update.

B. Fence Committee update: waiting for snow melt.

Update from Jon Herwig: once snow has melted, contractor will repair the fence and complete the remainder of the project, ideally beginning around mid-May.

Public Comment: Jane asked if they would do the repair the same way as initial construction? Trustee Scott mentioned Jon is getting the Construction company and the Design company together to discuss compliance with the plans regarding nails vs. screws, which side of the fence should boards have been mounted, etc.

Trustee Richard points out that RO Anderson was supposed to supervise the construction company to adhere to the design plans.

Trustee Nancy points out that our old fence design used metal fasteners and lasted since the 1960s, why didn't they use similar construction methods?

Resident Larry points out that if fasteners were stronger, boards might have broken, we don't really know if the boards are substantial enough.

Andy Geisse (1074 Skyland Dr) agrees it is a fastener issue. Nails too small, driven in too far, no screws.

Trustee Richard points out cross rails were supposed to be pressure treated.

Andy: perhaps we can find a construction savvy neighbor to volunteer to supervise.

Trustee Karl has questions about the designed load rating for the fence to resist pressure from snow plowing.

Trustee Nancy asked about the dying pine trees. Scott is confident we're going to get those replaced.

C. Postponed: Beach Committee Update: Trustees Englekirk and Sullivan to develop recommendations for assignment of kayak racks in 2023
