# 3. FOR DISCUSSION AND POSSIBLE ACTION

A. Approve minutes for 2023-10-05 meeting.

Trustee Nyre: Motion to approve the 10/5/2023 Minutes Trustee Beulieu: second Unanimously passed

B. Review possible change to fence configuration (move pickets to Hwy 50 side of fence) President Sullivan: Current contract has pickets on the Myron side of fence. Initial bid to move them was \$97K. The contractor has now agreed to install the pickets on the Hwy 50 side for \$10K. USDA (loan agency) has indicated they prefer the pickets on the Hwy 50 side. RO Anderson has indicated it meets the engineering requirements.

Public Comment:

Tim Lim (136 Ponderosa): Wanted to understand the advantage of putting the pickets on the Hwy 50 side. (Snow slinging dynamics explained) Michelle Kirby (136 Ponderosa): Why \$10K? (Itemized basis not provided) Simer & Veer Mayo (74 Skyland Ct): Does flipping the pickets invalidate the warranty? (No) Veer Mayo (74 Skyland Ct): Are they removing the concrete? (Yes)

Trustee Comment: Trustee Nyre: Discussed small business dynamics Trustee Ney: There are trust issues with this supplier but it is important to make this change.

Trustee Beaulieu: What is the timeline (original estimate was 10d, now it is 4-6 weeks as over 200 posts must be replaced.

Trustee Sullivan: Original proposal had itemized line items:

\$ 22K for demolition (they are doing this at their own expense this time)

\$140K for parts and labor for fence (they just bought \$33K in posts and rails for the rebuild at their own expense)

This is just for comparison to the \$10K.

Trustee Nyre: How much is the change order for the man-gates? \$1450 per gate, NV Energy now agrees we only need 1. Since the man gates were RO Andersons "oversight", are they willing to provide

Engineering oversight to the rebuild for less? Was not discussed, they are charging us \$4200 per week – this is \$100 per hour.

Trustee Nyre moved to approve the motion to flip the pickets on the fence for \$10K. Trustee Ney seconded. Vote is unanimously in favor.
