2. PUBLIC FORUM

Elisabeth Lernhardt 150 Willow: Please invite Cherise Smith to address the Board. Cherise is on the Recreation Advisory Board and has insight into the plan for Bike Trails.

3. FOR DISCUSSION AND POSSIBLE ACTION

A. Approve minutes for 2023-11-29 meeting.

Public Comment: none Trustee Comment: none

Motion to approve: Trustee Nyre Second: Trustee Beaulieu Unanimously passed.

B. Selection of Officer positions for 2024

By law, officer positions need to be established and/rotated at the first meeting of the calendar year.

Trustee Nyre pointed out that she has only been in place for less than a year, with a Request that she maintain the Secretary position. Trustee Beaulieu motioned to approve, Trustee Englekirk. Seconded, passed unanimously. After brief conversation with no trustees interested in a different Positional assignment, Trustee Nyre motioned to maintain Trustee Sullivan as President, Trustee Englekirk as Vice President, Trustee Ney as Treasurer. Trustee Ney seconded the motion. Motion passed Unanimously.

C. Trustee Committee Assignments (possible action)

It is important to get our committees going this year as there are a number issues that need to be addressed. By-laws require a trustee to be assigned to each committee. Committees are for research/discussion. Recommendations must be presented to the Board for decisions/funding.

D. Fire Hydrant Status and Updates needed (possible action)

Kris Rowlette (TDFPD Fire Inspector) and Trustee Nyre performed a survey of the fire hydrants in the neighborhood. Results presented (See Attachment A). Fire Inspector Rowlett added some detail about current residential fire concerns based on recent experience and the risk of lithium batteries.

Public Comment: None

Trustee Comment: Multiple trustees mentioned examples of concerns with lithium batteries (e-bikes, snowplows, etc).

Trustee Nyre requested that the appropriate course of action on the fire hydrants that do not meet code or have lower flow rates that we advise the Water Utility and request an action plan for resolution. Motion to approve: Trustee Englekirk, Second: Trustee Beaulieu. Motion passed unanimously.

A. Treasurer's report (discussion only).

Treasurer's report presented (Attachment B)

Public Comment:

Elisabeth Lernhardt 150 Willow: advised that the reserve account should be an interest bearing account with good rates available currently.

B. Fence update (discussion only)

80-90% of posts have been reset (all holes verified for dimensions by RO Anderson). 18 or so have not been reset. Contractor was advised about concerns about the crooked rails. When the pickets are installed, the rails will not be seen from Hwy 50 although it will be evident from the Myron side. Work will continue as snow subsides. Report from the landscaper on the dead or dying trees states the position that some died due to shock and some due to overwatering. We do not agree with that position and will push for full resolution, but not until the fence is complete because there could be more damage to trees resulting from fence reconstruction. (Secretary note: there was a discussion about tree health during the committee report portion of the meeting with Trustee Beaulieu reporting that Larry Lewin's (119 Ponderosa) arborist had evaluated the trees and had findings/recommendations that will help our position). The new lights are now energized. There is still confusion by NV Energy relative to the billing and who the contact person is for Skyland. Lastly: the light at the intersection of Willow and Myron has been repaired, although Trustee is asking the contractor for a more permanent solution so the low voltage lines will not knock it off again.

Public Comment:

Elisabeth Lernhardt 150 Willow: the low voltage line could be AT&T or Spectrum.

Vicki Bergstrom 194 Carson: Thank you for trying to resolve the fence.

Bob Pavich 1002 Skyland (Question emailed to Trustee Englekirk): Is there any way to get out of the fence contract? Did we pay for the contract upfront? Supplier is in breach of contract, we should get our money back. (Secretary note: these questions have been answered over a number of GID meetings, a short summary answer can be found on the recording for the meeting).

C. GID Trustee Election (2024 election cycle). ALL Trustee seats up for election (discussion only)
All trustee positions are up for election during the 2024 election. Although many of the current trustees are planning on running, we invite any qualifying resident to run for the open positions. We will be

Public comment:

Elisabeth Lernhardt 150 Willow: She advised that this issue came up because 2 people appointed to the Elks point sewer board were not residents on the voter roles of Douglas County. The DA Doug Richie also pointed out that there is no issue with someone being on the GID AND another board (ie, Fire, Sewer, etc). There has been some confusion about that in the past as it was believed to be a conflict of interest.

B. Hwy 50 & Bike Path

Hwy 50 Lane reduction: Not being pursued by NDOT

The Douglas County Trails Plan was presented to the BOCC last week, identifies that current plan is to bring the bike path through our neighborhood along Myron and behind Willow on the USFS land (paved path) down closer to the shore. Please see Attachment D. The map showing the new Lake Link coverage map (comes out to Round Hill Shopping Center). This is a service for free rides within the coverage area (works similar to Uber but free)

Public Comment: Elisabeth Lernhardt 150 Willow: reiterated that it is important to engage with Cherise Smith on the counties plans.

Trustee Comment: Trustee Ney, how many bikes will actually use the path? Why don't they put it on the USFS land on the east side of Hwy 50.

Trustee Englekirk met with DCSO and filed a Code Enforcement Complaint form as advised by DCSO to enable enforcement of unauthorized Kayaks on the beach.



Fire Hydrants

- There are 21 Fire Hydrants in Skyland.
- 7 Fire Hydrants appear to be original to the neighborhood (late 50's, early 60's style).
- 8 Fire Hydrants do not meet code because they are too low to the ground.
- 1 Fire Hydrant has the wrong main valve diameter (4" vs 6")
- The colors (base or cap) do not meet the current standard to aid critical firefighter timelines

- The Fire Hydrants are the responsibility of the Water Utility
- The Fire Hydrants are in the Skyland GID right of way

 - Potential FH replacement
 - · Potential addition of riser
 - Potential painting of FH w/ cap color correlated to flow rate

To date, I have not seen a snow removal invoice or an invoice from the engineering firm for the project management of

the reconstruction of the fence fall of 2023. I will work to have complete budget projections and payable listings for the

February meeting.

USDA Loan Amount: \$652,590.00

2.125% / 20 year Loan Start Date: 3/29/2022

USDA Fence loan payment \$3,485.00/month #4 Debt Service Coverage Ratio (DSCR)

Reserves held per contract: \$348.50/month starting January 1, 2023.

No reserves have been held to date. The GID needs to open another bank account to put the reserves in but have not

done so yet because of talks to change banks from US Bank to another bank due to customer service issues.

The total amount needed in the reserve account is one year's payments totaling \$41,820.00.

This would equal 120 payments of \$348.50. (10 years to withhold funds starting January 1, 2023)

2023 12x348.50 = \$ 4,182.00

2024 1 x348.50 = \$ 348.50

Past due total to apply to new withholding account: \$4,530.50

Per the agreement, we are NOT required by the loan agreement to complete another USDA audit concerning the fence

project.

Per my understanding and talks with the USDA loan team and per the information included in our loan agreement, the GID is only

responsible for audits at a NV state level moving forward in 2024. Skyland is not required to perform another full audit as was done

in 2023 per the loan agreement and per the funds that were expended. See USDA contract notes below. Financial statements can be

prepared and submitted by our current CPA firm.

Contract Notes:

a. An annual audit under the Single Audit Act is required if the recipient expends \$750,000 or more in Federal financial assistance per fiscal year. The total Federal funds expended from all sources shall be used to determine Federal financial assistance expended. Expenditures of interim financing are considered Federal expenditures.

All audits are to be performed in accordance with 2 CFR Part 200, Subpart F, as adopted by USDA through 2 CFR Part 400. Further guidance on preparing an acceptable audit can be obtained from the Agency. The audit must be prepared by

an independent licensed Certified Public Accountant, or a State or Federal auditor if allowed by State law, and must be submitted within 9 months of the recipients fiscal year end.

b. For local governments and Indian tribes, an audit in accordance with State or local law or regulation or regulatory agency requirements must be submitted when you expend less than \$750,000 in Federal financial assistance per fiscal year. These

audits shall be submitted to USDA no later than 150 days after the end of the borrower's fiscal year.

c. All borrowers exempt from USDA audit requirements and who do not otherwise have annual audits, will within 60 days following the end of the borrower's fiscal year furnish USDA with annual financial statements, consisting of a verification of the organization's balance sheet and statement of income and expenses. The recipient may use Form RD 442-2, "Statement of Budget, Income and Equity," (the Skyland GID accounting firm should be able to provide these documents) Skyland General Improvement District 03/29/2022

and 442-3, "Balance Sheet," or similar format to provide the financial information.

d. NOTE: As a part of the normal RD Servicing Requirements, the Applicant will be required to provide RD with annual audited financial statements and also quarterly financial reports. Quarterly financial reports are only required for the first year of the loan.

2. Audit agreement—If you are required to obtain the services of a licensed Certified Public Accountant (CPA), you must enter into a written audit agreement with the auditor. The audit agreement may include terms and conditions that you and auditor deem appropriate.

I completed the Pool Plan insurance questionnaire and submitted it to our insurance provider A and H Insurance, 3301 So. Virginia

st., Reno, NV 89502. The GID is waiting for the updated insurance rider and 2024-2025 cost to review.

Entry Meeting - Tuesday January 23rd, 2024 - Notes / Report

Larry Lewin (119 Ponderosa) had his personal Arborist, Molly, access the Entry and existing vegetation/landscaping.

Molly recommended another landscape professional to access the Entry area next week for a second opinion of the current situation and make recommendations going forward.

The Pine trees are Bristle Pine and they are all the same. They are not salt tolerant and have been planted incorrectly with left over burlap, twine, and in some areas have had bark beetle infestation.

She felt that since there are five different pine trees indigenous to the area; they should have planted all five types and see which ones held up the best so close to HWY 50 with the on-going snow removal and ice melt.

Sandra Ney (1018 Alpine) drew up some 2 terrific drawings for the entry and has agreed to meet with Molly and her landscape professional before next month's meeting to get a better idea of the scope of the design.

Sandra Ney and Nancy Beaulieu (1036 Golden Mantle) discussed possible entry way designs and materials and if the design should be carried along Tahoe drive where the existing fence and Pillars exist. This would add some congruency to the project.

We all agreed that keeping things simple and elegant would be the best course of action.

Hwy 50 & Bike Path Update

- Hwy 50
 - NDOT is currently dropping pursuit of lane reduction on Hwy 50.
 - Gov Lombardo has requested that NDOT come up with alternatives to create turn lanes or other safety measures at critical intersections (ie, Presbyterian curve)
 - BOCC is working on a resolution to declare Hwy 50 a critical evacuation route that must remain at 4 lanes.

- · Bike Path
 - Douglas County has the position that bike lanes on Hwy 50 are too dangerous
 - Douglas County trails plan recently presented to BOCC show the bike path adjacent to the highway, but going through neighborhoods in some cases.
 - Current pictoral shows it going along Myron (within Skyland) and just south of Willow.
